## **WAIVER CONSENT, RELEASE OF LIABILITY, AND CERTIFICATION OF PHYSICAL FITNESS TO PARTICIPATE:**

1. By accepting this agreement and participating in MN Tough Camp, you agree that you understand that there is a risk of injury in participating in any sport, including wrestling. This risk of injury includes but is not limited to a risk of serious permanent injury, paralysis, and death.

Your agreement indicates that you understand that your child should not participate in the MN Tough Camp if: he or she is currently under the care of a physician for and injury or illness that would prevent his/her safe participation in Wrestling events; he or she is currently being treated for or recovering from an orthopedic injury that would prevent his/her safe participation in Wrestling events; your child has a history of fainting or other problems related to strenuous exercise; or your child is not in good health or has some other reason he or she should not participate in strenuous physical exercise.

To minimize the risk of injury, you agree to tell your child to obey all safety rules and to report fully any problems related to his/her physical condition to the MN Tough Camp coaches as soon as the problem begins.

2. By accepting this agreement, you certify the following:

- That you are the parent or legal guardian of the child (athlete) named below.
- That your child is not currently under the care of a physician for and injury or illness that would prevent his/her safe participation in the MN Tough Camp.
- That your child is not currently being treated for or recovering from an orthopedic injury that would prevent his/her safe participation in the MN Tough Camp.
- That you acknowledge Ponce Trained Wrestling is a privately-owned company and is not business associated with the National Sports Center, Pursuit Fitness, the United States Army and Armed Forces, and Rudis Gear.
- That your child has no history of fainting or other problems related to strenuous exercise.
- That your child is in good health and there is no reason he or she cannot safely participate in strenuous physical activity.
- That your child has a valid USA/MN Wrestling Membership, current for the 2019-2020 year.
- That you have health insurance which provides adequate coverage for injuries or illness your child may sustain while participating in the MN Tough Camp.

3. CONSENTS:

1. By indicating your acceptance of this agreement, you hereby give permission for PTW and MN Tough Camp employees and associates to obtain medical treatment for your child in the event of accident or illness during his/her time at MN Tough Camp.

2. By indicating your acceptance of this agreement, you hereby give consent to have your child be photographed or videoed during camp activities, and you agree that the images obtained may be used for educational and public relations purposes by the MN Tough Camp.

RELEASE:

1. By indicating your acceptance to this agreement, you do hereby agree that you are and shall be responsible for all costs associated with any injury, illness, damage, expense, claim, or loss that may be sustained by your child as a result of his or her participation in the MN Tough Camp. You also certify that you have health insurance and a valid USA/MN Wrestling Membership current for the 2019-2020 year which provides adequate coverage for injuries or illness your child may sustain while participating in the MN Tough Camp.

2. By indicating your acceptance of this agreement, you also agree to release and promise not to sue PTW, MN Tough Summer Camp, the National Sports Center, Pursuit Fitness, the United States Army and Armed Forces, Rudis Gear, Mr. & Mrs. Ponce, or the officers, employees, or agents, for any injury, illness, damage, expense, claim, loss, injury, or death arising from, resulting from, or in any way caused by your child's participation in the MN Tough Camp.
